The first driving license is limited as a beginner driving license. During this period towing is not permitted. Most countries allow driving from the of 18 or above.

7. Applying to the course:

You can apply to the course during our open hours after informing us.
You will have to fill out a form of application. You will need to bring your valid ID, Driving license (if you had any before), adress card.

8. Required medical test: -B: 1. class medical test

9. Conditions of enrolling to the course, and the exams:

One can apply for the course if they have completed 8 years of elementary education and can prove it by presenting the original certificate. The applicant must not be more than six months younger than the required age, has filled out the application form, and has the necessary qualifications if applicable. A copy of the original health suitability certificate is also required. If the student already possesses a driving license, it must be presented.

Another requirement is the signing of the study contract. In the case of students under the age of 18, the contract must also be signed by their legal representative. The theoretical course must be completed within:

9 months to take the theoretical exam, a deadline the student must adhere to.

1 year to pass the theoretical exam successfully. Failure to do so obliges the student to repeat the course.

Within two years from the date of passing the theoretical exam, the student must pass the practical driving test. Failing to do so requires the student to complete both the theoretical and practical training again to obtain a driving license.

A student can take the theoretical exam if:

They have completed the theoretical part of the course or received an exemption.

They meet the specified health and professional suitability conditions according to the law and have made a written declaration regarding the specified traffic safety conditions.

They are participating in e-learning and have a training certificate.

The exam date is scheduled according to the available examination slots by KAV (an authority in this context). The exam is conducted on a computer in Tatabánya (2800 Tatabánya, Táncsics Mihály út 1/d), and the student is responsible for their own transportation. The student must prove their elementary education to the authority on the first day of the exam (by presenting the original certificate). Failure to do so will result in the student not being allowed to take the exam.

If the student already has a driving license, it must also be presented during the theoretical exam. Ways to prove elementary education include presenting:

The original document or

A copy certified by a notary or the issuing authority, or

In the case of foreign certificates, the original document and its certified translation (not mandatory if the content and format are in line with the "Certificate and Diploma Pattern" created by the traffic authority). Alternatively, a Hungarian authority with jurisdiction may issue a recognition decision, homologation endorsement, an official certificate, or a notification not older than three months.

A student status certificate issued by a higher education institution in Hungary, stating that the certificate or diploma confirms at least a basic level of education or implies its existence.

The certified translation might take some time; it's advisable to arrange it immediately after applying for the course.

To take the practical exam, the student must:

Have reached the age specified in the law for issuing a driving license.

Have passed all theoretical exam subjects.

Meet the conditions stated in the medical suitability report (e.g., wearing glasses; without these, the exam cannot be taken).

Complete the practical driving part of the training.

Cover 580 km during the practical training.

If the student already has a driving license, it must be presented during the practical exam.

A condition for issuing the exam certificate is that the student has passed all exam subjects, passed the first aid course, and presented the corresponding certificate at the Registration Office (in the case of the first driving license). Afterward, the Registration Office issues the driving license. There is no longer a physical exam certificate; the data is transmitted electronically to the Registration Office.

10. Driver's Training Courses, Subjects, Lessons, and Durations:

Category "B":

Theoretical Training: 28 lessons (including: traffic knowledge 18 lessons, driving theory 6 lessons, structural and operational knowledge 4 lessons) The duration of theoretical classes is 45 minutes.

The above theoretical lessons can also be fulfilled or replaced with e-learning training.

Practical Training: Mandatory total lessons: 29 lessons, composed as follows:

Basic Training: 9 lessons

City Driving: 14 lessons

Highway Driving: 4 lessons

Night Driving: 2 lessons

Traffic Exam: 1 lesson The duration of practical driving lessons is 50 minutes each.

12. Course Absences:

Participation in theoretical training is mandatory.

Exemptions from attending the theoretical subjects of the course cannot be granted if the applicant possesses the qualifications listed in Annex 3 of Regulation No. 24/2005 of the Ministry of Economy and Transport.

Any missed theoretical classes must be compensated. The fee for compensating absence is 4,500 HUF per hour.

Absences must be made up at a time agreed upon with the theoretical instructor.

For students, the completion of the training is considered by the traffic authority and the examination center to be fulfilled only if, based on the curriculum and attendance sheets sent to the examination center, the student has attended theoretical classes in the classroom for the total number of hours specified in the training, without additional compensatory classes. In case of absence, the student must attend additional classes on the topics missed. These additional classes must be incorporated into the curriculum and reported according to the regulations governing curriculum modifications. In the case of e-learning training, all modules and exams of the training must be completed.

When making the transfer, please indicate the full name of the student in the remarks section. The student must settle the entire course fee to be eligible for the driving exam.

14. Exemption Criteria for visiting and Examining Individual Subjects:

Students who possess the qualifications listed in Annex 3 of Regulation No. 24/2005 of the Ministry of Economy and Transport are exempted from participating in the sessions of the respective subject of the course. The school director grants exemptions upon presentation of the original certificate.

To initiate exemption from the examination obligation, a photocopy of the document serving as the basis for exemption must be attached to the application form. The exemption from the examination obligation is authorized by KAV through an entry made on the application form.

15. Student Transfer and Issuance of Certificates for Completed Education, Consequences of Student Transfer:

If the student wishes to continue their education at another training provider, it is considered a termination of the contract. In this case, the student must pay any discounts received from the school as well as the driving lessons that were conducted but not paid for.

After settling any outstanding balances, the necessary documents for the transfer will be issued within 3 working days, which the Driving School must provide to the student.

17. Requesting Additional Lessons, Fees:

Additional lessons can be requested by coordinating with the instructor. The fee can be paid during customer service hours at the office or via bank transfer to the driving school's account.

19. Rights and Obligations of the Exam Candidate:

Right to Pay Practical Training Fees in Installments: The student has the right to pay the practical training fees in installments.

Obligation to Pay Theoretical Training Fees upon Contract Signing: The student must pay the theoretical training fees upon signing the contract.

Obligation to Follow Safety Regulations: It is the student's obligation to adhere to general safety, health, occupational health, and fire safety instructions during the training.

Obligation to Preserve Training Facilities: The student must preserve the premises, equipment, tools, and facilities used for teaching and examination.

Obligation to Attend Practical Training: The student must attend practical training sessions at the agreed time and place.

Right to File Complaints: The student has the right to submit written complaints to the school principal and receive a response within 30 days.

Right to Choose Instructor: The student has the right to choose an instructor or change instructors during practical training. However, this may lead to an extended waiting period for practical training sessions.

Obligation to Behave Respectfully: The student must behave respectfully during sessions, appearing in a sober and well-rested state.

Proper Use of Training Equipment: The student must use training equipment appropriately, preserve it, and follow the instructor's instructions.

Prompt Reporting of Complaints: The student must report complaints in a verifiable manner as soon as possible.

Obligation to Follow Instructor's Instructions: The student must follow the instructor's instructions. Failure to comply repeatedly gives the training provider the right to terminate the contract, and the parties settle their accounts. Liability for

Damages: The student is liable for damages caused.

20. Exam Fees and Payment Methods:

Category "B" Exam Fees:

Theoretical Exam Fee: 4600 HUF

Practical Exam Fee: 11000 HUF

Payment: The student pays the exam fees individually for each exam element or as a lump sum, either in person during customer service hours or via bank transfer.

In case of a retest, the same exam fees apply.

Cancellation of Exam: The exam can be canceled up to 5 working days before the exam date (during office hours). In this case, there is no need to pay the exam fee again.

Illness: If the student is unable to attend the exam due to illness, the certificate must be submitted within 8 calendar days from the missed exam date or, if the submission of the certificate is hindered, within 8 calendar days from the cessation of the obstacle. Missing this deadline results in forfeiture of rights, and appeals for leniency will not be considered

The prices are valid and the same for e-learning.

For any initiated theoretical training, there is no possibility of refunding the training fee.

The driving school can offer discounted training. In this case, the study contract determines the training fee.

In case of subject exemptions, the training cost remains unchanged; only the exam fee is adjusted. For e-learning training, the access time is 75 hours/180 days. After registration is sent, there are 60 days available to start the course. Upon expiration, a payment of 10,000 HUF is required, providing an additional 10 hours/30 days of access.

The student must have the necessary computer access and knowledge for e-learning training.

Cancellation Policy: If the student cancels within 24 hours of the agreed driving time, they are obligated to pay the instructor's fee. The agreed-upon time must be adhered to; lateness is not acceptable. The driving school reserves the right to change the training fee.

22. License Issuance Conditions:

A driving license is issued to those who meet the specified health, career aptitude, training, and examination requirements defined by separate regulations. A driving license can only be issued to Hungarian citizens or citizens of EEA (European Economic Area) member states with a residence permit, whose place of residence, or in the absence of that, whose place of stay (accommodation) is in Hungary. In the case of non-Hungarian citizens (hereinafter: foreigners) applying for a license, the applicant must have stayed in Hungary for the six months preceding the issuance of the license.

To prove the six-month stay in Hungary, the applicant must present the relevant permit from the immigration authority.

For foreign citizens, the six-month stay requirement is not applicable if the application is for a replacement of a previously obtained domestic driving license or for the naturalization of a foreign driving license obtained abroad.

If the applicant acquires driving privileges in Hungary that they did not previously possess, the rules for naturalizing a foreign driving license must be applied.

23. Additional Information:

The driving school does not organize a first aid course. However, students have the option to complete this course through the elearning material for an additional fee. This request must be made during enrollment. The first aid examination is conducted by the Hungarian Red Cross, who is authorized to certify first aid skills. Please note that there might be a waiting period for practical training, and the training center does not take responsibility for this delay.
